Kena Wraps LLC is 100% Black & women-owned; every day is a celebration of their family legacy as New Mexico business owners. Established in 2021, Kena Wraps designs head wraps and wave caps and sells other hair accessories. Kena Wraps was awarded a full utility patent

from the USPTO in 2022. Sales are on the rise through their online boutique kenawrap.com and the premier beauty supply, Trendz (Albuquerque). Kena Wrap's successes include a feature during 2022's LA Fashion Week, contracts with NM Indian American Chamber of Commerce to employ Indigenous women in the manufacturing process, and featured segments on KOAT 7 News. Juperi was WESST's 27th HOPE Loan client since the program was launched in 2020.

As a woman and a woman of color, Ms. Parker has experienced a lifetime of going to doctors and being treated dismissively and disrespectfully. There are known and

well-documented biases in the healthcare system against people of color, most adversely impacting African American women. This motivated Ms. Parker to pursue a lifelong commitment to serve women in medicine. Daija found the practice of Ultrasound rewarding, and she started one of New Mexico's only mobile ultrasound services. Daija provides this and many other services to expectant mothers throughout southeastern New Mexico. Daija graduated from UCLA with a BS degree in Molecular Cell Development and has earned many medical certifications to practice Imaging and Radiation Therapy in New Mexico. Daija has had to fight to prove herself regardless of her race, education and over 25 years of experience in the field.

One element of success resulted in a specific marketing campaign for the Christmas Holiday season that helped Sara exceed her sales goals.

Brenda is a woman with a mission who came to WESST pre-pandemic seeking help with her husband's landscaping business. After being the main bookkeeper for a business for several years,

she wanted to start her own business, specifically, serving clients in the Spanish-speaking community who were having difficulty either starting or keeping their accounting in order. That's when Brenda reached out to WESST Santa Fe and started taking workshops and consultations to discuss her idea and how to get started. WESST continues to coach her to approach her work as a businesswoman, and to value her time and expertise in setting up payment plans with clients, so they could have access to her services. Brenda is now a new mother of a beautiful baby girl, and she keeps busy with her full-time job and her bookkeeping business. Most of her clients do not speak English. She is also assisting other nonprofits with projects on the South Side of Santa Fe.

SPECIAL PROGRAMS

Native Women Rising

Through WESST's Native Women Rising project, our goal is to engage Navajo women in entrepreneurship as a means to increased financial self-sufficiency. Native Women Rising presents an opportunity to diminish the disparities between marginalized Native individuals and economic opportunities by providing culturally relevant small business, financial and entrepreneurial resources within New Mexico Native communities. This curriculum supports Native women in learning about all aspects of running a business, including relevant legal considerations if the business is reservation-based. WESST appreciates the generous support received from Wells Fargo, which made the inaugural year of this program possible. HOPE Fund

To address historical challenges faced by Black, Indigenous and people of color (BIPOC) when accessing capital, WESST launched the HOPE (Helping Open Possibilities for Everyone) Fund in 2020. A key barrier to accessing capital is the lack of initial wealth, which particularly impacts BIPOC entrepreneurs. The HOPE Fund removes barriers by offering 0% interest loans with no fees, and the opportunity to have a portion of the loan principal forgiven. Poor credit and lack of collateral are not factors in whether a HOPE applicant is approved for a loan. In 2022, WESST extended 14 HOPE Loans totaling \$154,864. WESST partners with GoDaddy to help equip entrepreneurs with training, tools and peer networks to improve their digital presence and online marketing efforts. Artist Think Tank

WESST's Artist Think Tank pilot series, spearheaded by our Santa Fe regional office in 2022, confirms there are great benefits for all when artists have a platform to communicate directly with each other about important topics. One of the most common causes of small business failure is financial mismanagement. Without financial knowledge, systems or processes, it is difficult to successfully start and sustain a business. In 2019, WESST launched the Money Learning LabTM, a unique program that helps diverse entrepreneurs address the financial challenges in their businesses. Each Money Learning LabTM series is offered in neighborhoods and communities across New Mexico

in partnership with other community-based organizations. In 2022, WESST organized 10 unique series across the state that served 200 clients in both English and Spanish. The program incorporates Human-Centered Design principles to engage entrepreneurs in crafting their own solutions to learn, apply and implement systems and sound financial practices.

WESST Incubator

Emerging businesses who are members of the WESST Incubator receive operational support and resources that help accelerate growth during the critical start-up phase and encourage long-term success. The facility is equipped to house businesses in many industries, including artisan manufacturing, digital media production, information technology, and business and consumer services. Today, the incubator is home to small business members in the technology, non-toxic chemical manufacturing, jewelry, professional staffing, and biotechnology industries. To date, member companies of the WESST Incubator created a combined total of 433 new jobs with a total payroll of \$67.3M, have \$169.7M in revenues, and raised \$20M in equity investments.


- 38 Loans, Totaling \$677,264

Training & Consulting

Our training programs focus on the skills needed to start, run and grow a successful business, including strategic planning, business planning, marketing and accounting. WESST consultants serve as professional one-on-one business trainers and advisors providing expertise in management, finance, sales and marketing, web marketing and social media.

Low Cost Loans

WESST's loan program focuses on providing under-served populations including women, BIPOC and low-income individuals with low-cost loans for their businesses. Incubation
